Ministry of Government Legislation Shared Korea's Legislative Improvement Experience with Cambodia

- Presenting "Regulatory Innovation to Transform Economies and Facilitate Investment" at "Legal Reform Workshop" hosted by the Office of the Council of Ministers of Cambodia

The Ministry of Government Legislation (Minister Lee Wan-kyu) visited Cambodia's "Legal Reform Workshop" on Monday, to share Korea's legislative improvement experiences at the invitation of the Office of the Council of Ministers of Cambodia.

The workshop was attended by approximately 250 participants, including officials from Cambodia's Office of the Council of Ministers and the Ministry of Economy and Finance, as well as experts from aid organizations and universities. The delegation of the Ministry of Government Legislation was arranged following a meeting between Lee Wan-kyu, Minister of Government Legislation of Korea and VONGSEY Vissoth, Deputy Prime Minister and Minister of the Office of the Council of Ministers of Cambodia, on Thursday, October 31, where they discussed legislative exchange and cooperation, the Deputy Prime Minister of Cambodia formally invited the Ministry of Government Legislation's officials to attend Cambodia's "Legal Reform Workshop" in December.

Ryu Cholho, Legislative Deliberation Officer of Legislation Bureau of Administrative Affairs of the Ministry of Government Legislation,

presented Korea's experience in "Regulatory Innovation to Transform Economies and Facilitate Investment" as a case of legislative improvement of Korea at the workshop on Monday, December 16. Following his presentation, Cambodian legislative officials engaged in a discussion session, asking questions about Korea's experience and discussing ways to advance Cambodia's legislative development.

On December 17, the delegation met with SEA Mao, Secretary of State of the Office of the Council of Ministers and Vice Chairman of the Council of Jurists, to discuss ways to enhance legislative exchange and cooperation between the two ministries. In particular, to establish the Council of Asian Legislative Institutions (CALI), they introduced the topics to be discussed at the Preparatory Committee for CALI and committed to cooperation.

“Cambodia is a country with high growth potential, and economic cooperation with Korea is expected to expand further,” said Minister Lee Wan-kyu. “Based on Korea's legislative development experience, the Ministry of Government Legislation will strengthen legislative exchange and cooperation to promote Cambodia's legislative development, and through this, support the advancement of cooperation between the two countries.”
